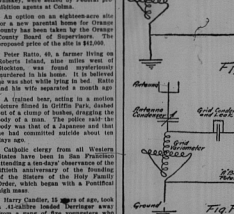
HONEYCOMB COILS IN CONVERTING RECEIVER

Third Regenerative Circuit Arrangement is by Electrostatic Coupling.

In making a receiving set over the regenerative circuit, the "Honeycomb" coils are very well adapted to a circuit arrangement as shown in Figure 1. One coil is used as a primary, a second coil as a secondary, and a third as a triode or plate inductance.

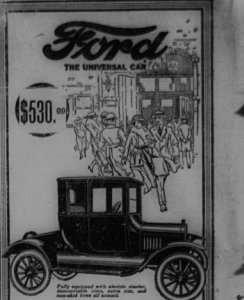

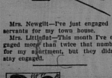

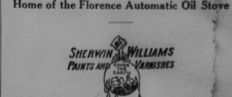
