## **Environmental Updates**

Chatsworth Reservoir — The Department of Water and Power is developing a Concept Study for Chatsworth Nature Preserve/Reservoir. The plan may include a long-term lease agreement for the entire site to be managed by a conservation organization. It could also include controlled public access for educational purposes or opening the park to the public for passive recreation (no ball fields) or dogs in the Preserve). Perhaps with management by a conservation-oriented agency such as the Santa Monica Mountains Conservancy which owns Sage Ranch and the new Rocky Peak Park, both in the Simi Hills, much of the Nature Preserve will be allowed to return to an unmanicured natural oak savannah. (Have you seen the graceful form of a Valley Oak as its limbs sweep to the ground?) Please write, call, fax, e-mail Councilman Hal Bernson of the 12th District, expressing your feelings on the matter. Our opinions are counted.

Dayton Canyon — The final Environmental Impact Report is now available at your library. Thanks to all those who wrote responses to the draft form! In the revised project plan, the impact to the Coast Live Oak woodland was reduced from 2.38 acres to 1.26 acres, affecting 56 fewer oaks. The area dedicated to permanent open space will be expanded from a minimum of 214.4 acres to possibly 270 acres. The total number of lots was reduced and the 230-foot high cut slope was eliminated, along with reductions of cut and fill in the grading plan. The developer will work to provide a public trail system to the dedicated open space. The water detention basin in the heart of the oak woodland remains in the plan. I wonder if the Cooper's Hawk living there will also remain. 🏶

## May 17th Program

Henry Schultz, chair of the Santa Clarita Group of the Sierra Club and a frequent hike leader in the Santa Susana Mountains, will present a slide show on Towsley Canyon, Elsemere Canyon, Sunshine Canyon, and the Santa Clarita Woodlands. He will show Sunshine Canyon before most of its trees were cut down to make a trash dump and will tell us about hiking opportunities in the Santa Susanas.

This program will be of special interest because we are trying to place funds on the next California State Bond Proposition for parks, open spaces, etc., to purchase property that will complete the Wildlife Corridor from the Santa Monica Mountains, through the Simi Hills and Santa Susana Mountains, to the Angeles National Forest and the Santa Clarita River (the latter is about six miles from the Los Padres National Forest).

The General Membership Meeting starts at 7:30 p.m. at Rockpointe Recreation Center, 22300 Devonshire, Chatsworth (south side of street), one block before entry to Chatsworth Park South.

### June 21st Program

At our June 21st meeting, SSMPA member Barbara Coffman will present a slide show of the history of the Old Stage Coach Trail, which is part of the Santa Susana Pass State Historic Park. Come to this presentation and then join Barbara on the Sunday, June 26, hike in the State Park, starting at 9:00 a.m. from the Chatsworth Park South parking lot and lasting about 3 hours. Wear lugsole shoes and a hat; bring water and food; and use sun block.

## **Unveiling Our Park's Signs**

One highlight of the March 20th 60th Anniversary of the Placing of the Old State Coach Trail Plaque was the unveiling of one of six signs for the new Santa Susana Pass State Historic Park. The signs were financed through a contingency fund, a \$1,000 grant to the California Department of Parks and Recreation by the Foundation for the Preservation of the Santa Susana Mountains (FPSSM).

Four of the six signs will be installed inside the new park's borders, with two kept in reserve. Locations for the sign will be: the South Entrance near Larwin Avenue; the Central East Entrance bordering with Chatsworth Park South; the Northwest Entrance, paralleling Old Santa Susana Pass Road; and the Western Border near Lilac Lane, close to the Ventura County line. It takes two hours to install each sign. We hope to have the Central East Entrance sign installed in honor of May Is State Parks Month, as well as of the anniversary of the State Historic Park's dedication on May 16, 1998.
