

RECENT ENVIRONMENTAL VICTORIES SET UPBEAT TONE

As the year draws to a close, residents of the Northwest Valley have a lot to be thankful for:

- Our State Government approved the Villaraigosa-Keeley environmental bond act, and placed it on the March 2000 ballot as State Proposition 12.
- The Santa Monica Mountains Conservancy bought five acres of open space northwest of the Ventura Freeway and Liberty Canyon interchange. The land, which had been slated for commercial development, will now be kept as open parkland with a trailhead for hikers. Not only that, the land contains another link in the corridor that lets wildlife roam from the Simi Hills and the Santa Susana Mountains to the Santa Monica Mountains, and back again — this part of the wildlife corridor will now be preserved.
- The Board of Water and Power Commissioners approved keeping the entire 1,326-acre Chatsworth Reservoir as a nature preserve. At the present time, the DWP will continue maintaining the nature preserve, while they negotiate with potential partners for the preservation of the site as a valuable environmental, historical and cultural resource. An advisory committee will be formed to maintain community involvement in the nature preserve.

Programs for Jan. & Feb. General Membership Meetings

Archaeologist and SSMPA Member Al Knight will present a program on local Native American rock art at our January 17th meeting.

Naturalist Sean Manion of the Santa Monica Mountains Resource Conservation District will present a program about coyotes and other large mammals in the area at the February 21st meeting.

General Membership Program Meetings take place at 7:30 p.m., on every third Monday of the month, at the Rockpointe Recreation Center, 22300 Devonshire, Chatsworth (so. side of street), one block before entry to Chatsworth Park South.

While this latest position on the part of the DWP represents a great victory for Councilman Hal Bernson and all of us who want to preserve the entire site as a nature preserve, their ruling only ensures that no development is to be proposed at this time. Therefore, it may be prudent for a member of the SSMPA and perhaps other local groups to be on the advisory committee, which will meet quarterly.

We need to obtain permanent protection for the Chatsworth Nature Preserve. We urge one of the following actions:

- Designate the entire nature preserve as a conservation easement in perpetuity.
- Make the entire nature preserve a part of the State Park system by adding it to the Santa Susana Pass State Historical Park.
- Obtain federal designation, as proposed by Helen Treend and Ann Hinckley.

Swift action may be necessary as Hal Bernson's last term as a Los Angeles City Councilman will end on June 30, 2002. *

A Walk in the Garden of the Gods

It had rained the day before I visited the Garden of the Gods for the first time. I parked and walked up the old road built in the movie-making days. In less than five minutes, I entered into a garden of large boulders. Here was a close-up view of the unique Simi Hills rock formation. The rain-darkened colors of the boulders contrasted with the orange lichen blooming on their surfaces. A turn in the path revealed cracks and nooks damp with spongy moss. This magical world of rocks, part of the lverson Movie Ranch, was the venue for many of the old Western movies. I stood on a circular camera mount overlooking the stage coach road below. Across the road (now Red Mesa Drive), the picturesque Nyoka cliff, which was part of a cliff-hanger episode in the series "The Perils of Nyoka." A little north is the famous Lone Ranger rock.

This marvelous vista is very accessible. From Topanga Canyon Blvd., turn west on Santa Susana Pass Road, go about a half mile and turn left on Red Mesa Drive. Watch for the Santa Monica Conservancy sign on your left. *****

Park Planning, Garage Sale, and Bylaws

Dan Preece is scheduled to complete the Interim Management Plan for the Santa Susana Pass State Historic Park by mid-January, after which the plan will be submitted to State Park officials for their approval. The plan will reflect suggestions of members of the SSMPA, FPSSM, Chatsworth Historical Society, local community members, Santa Monica Mountains Conservancy staff, and local State Park officials. Approval of the plan will make our park eligible for funds from the \$500,000,000 State Park allocation included in Proposition 12. We'll need to convince the public to vote for Prop. 12. Volunteers will soon be needed to pass out literature at Topanga Plaza, the Fallbrook Mall, and Northridge Fashion Square.

Thanks to the donations and efforts of members of the SSMPA and of the San Fernando Valley Sierra Club, the SSMPA garage sale on November 6th was a resounding success. Proceeds of the sale are partially funding the Interim Management Plan of our Santa Susana Pass State Historic Park.

At the November 15, 1999 General Membership Meeting, a quorum of seven board members and ten other SSMPA members approved the 19th draft of the revised SSMPA Bylaws. The meeting also featured Judy Garris with her slides of the Santa Susana Mountain and Simi Hills trails. $\hat{*}$

LA County SEA Beview

Los Angeles County is conducting studies on whether to revise its Significant Ecological Area (SEA) designations. Among others, Dorian Keyser has submitted recommendations for the Chatsworth Nature Preserve and the Simi Hills; Judy Garris has submitted recommendations for the Simi Hills and Santa Susana wildlife corridor; Dave Brown has made recommendations for the Santa Monica Mountains; and Betsy Landis has submitted recommendations for all Los Angeles County SEAs.

We will continue to be involved in this process and later in supporting the preservation of SEAs from development. Please write or call your County Supervisor and ask them to support recommendations that favor preservation of local SEAs and all SEAs in the County. *
