WALT PARKER, EED and Executive Director of the William O. Douglas Nature Center, will present an illustrated talk about the "Early Days of Chatsworth and Environs". Born in 1920, Walt moved to Chatsworth on Memorial Day, 1929. His Grandmother (Lefferts) ran three bed and breakfast inns in Chatsworth, Simi and Moorpark, and his father drove a stagecoach over the Santa Susana Pass between them before the Railroad tunnel was completed in 1904. Walt knew the Iversons, and used to live in the same house as Pauline Aue in Twin Lakes. Walt is an interesting person with a lot to say. Be there!

MARGE FEINBERG, MS in Environmental Planning (CSUN) Marge's Masters Thesis was called "Rim of the Valley Park - Proposal for a Greenbelt Around the San Fernando Valley." #### CURRENT ISSUES

Jordan Ranch was sent back to the drawing board by the Ventura Co. Environmental Resources Review Committee. Hopefully, they will get closer to meeting the conditions of the So. Cal/Nev Regional Conservation Comittee this time.

AB 1152 (Friedman) is legislation that will give State Parks Dept. some say in regard to the proposed extention of Reseda Blvd...as it would intrude in the Topanga Cyn. State Park. Please call or write to Senator Ed Davis, 11145 Tampa Av., Northridge 91326... ask for his support.

The Soka property lies in the heart of the Santa Monica Mountains - National Recreation Area (SMMNRA), across from Malibu Creek State Park, and has long been considered as the prime location for a Park Visitor Center. It contains historical buildings and parking for an interpretive and staging area for visitors to the entire system.

Soka has lobbied both Sacramento and Washington DC to reduce the appropriation for NPS acquisition, and prevent NPS from condemning the property. This is a very crucial resource that needs to be in the public domain. Please write and ask the Senate Appropriations Committee, U.S.Senate, Washington DC 20510, the Honorable Robert Byrd, Chairman, to reconsider funding for the SMMNRA, and restore the \$14 million, as well as the ability to use eminent domain. Copies to Senators John Seymour and Alan Cranston.

## SSMPA NEEDS YOU! BE A DOCENT! NOW IS THE TIME!

The Sierra Club offers their leadership training only twice a year. Only one Saturday, a Red Cross Multimedia course (two evenings), and a couple of checkout hikes can qualify you to lead our Sunday hikes and any other hikes you might want to lead. It is excellent training for being out there with your family, too - whether or not you become a docent. You can also learn navigating (compass) skills for off-trail hiking or backpacking.
